Petition for Sealed Name Change

Instructions

- Step 1:** Find out if you are eligible for a **sealed** name change in Superior Court.
You can only file for a sealed name change in Superior Court **if at least one of these is true:**
 - Your request is due to an experience of or reasonable fear of domestic violence, stalking, unlawful harassment, or coercive control.
 - Your request is related to gender expression or identity.
 - You are an emancipated minor.
 - You have asylum, refugee, or special immigrant juvenile status.

If none of those apply, do **not** use this form. Contact **District Court** for their public name change forms.
- Step 2:** Check with the Superior Court Clerk to see if they have their own name change forms. If local forms exist, use them. Otherwise, fill out this form and a proposed *Order for Sealed Name Change* (NJP General 091). You may need additional forms like a Cover Sheet, Confidential Information Sheet or Notice of Hearing form. Ask the Clerk if these forms are required in your county and how to get them, if needed.
- Step 3:** File your petition with the court clerk. Pay the filing fee or apply for a fee waiver. Ask the court clerk how to schedule a hearing on your petition.
- Step 4:** Go to your court hearing. Bring ID and your proposed *Order for Sealed Name Change*. Ask the judge to sign your order. After the order is signed, you can purchase copies from the court clerk. Purchase many.
