

Sidee Kaga Jawaabaa Dacwad ah Dayn Ururin?

Qoraalkan wuxuu sharaxayaa Qodabada sharci, Xeerarka iyo kiisaska maxkamadda. Waxaan soo raacinaynaa **warqadaha amarka maxkamadda** haddii aad rabtid inaad samaysid baadhid. Taasi waa meesha aad ka heli doontid xog gooban.

Baqshaddan waxay kaa caawinaysaa haddii lagugu soo rogay dacwad kiiska dayn ururinda, iyo haddii aad rabtid inaad ka hortagto xukanka lacag bixinta ee dhaqaalahaaga iyo hantida ama mulkiyadda guri ee kadhanka ku ah hantidaada.

◆ Baqshadan ma ahan beddalka wakiilashada caadiga ah ee qareen. Ku dadaal inaad la hadashid ama aad qabsatid qareen ka hor ka jawaabidda warqadaha.

Ma ka jawaabaa Cabashada?

Haa, haddii aad aaminsantahay inaan lugugu lahayn qaar ama wax ka mid ah cadadka la sheegtay.

Ma inaan ka jawaabaa Cabashada?

Maya, haddii aad ogoshahay in lagugu leeyahay cadadka la sheegtay ama aadan doonaynin inaad ka doodo dalbashada.

Maxaa dhacaya haddii anan ka jawaabin Cabashada?

Dacwoodaha ayaa guulaysan. Dacwooduhu wuxuu heli dooaa xukunka waxa ay/uu ku codsaday cabashada.

Xataa haddii uu dacwooduhu guulaysto, waxaa jira xaddidaad ah waxa ay/uu samayn karo inuu qaato. Qoraalkanaga waxaa loo yaqaan sharaxaadda qoraalka [Xuquuqda Dayn-qaataha ee Dacwad](#).

Haddii aan lacag yar bixiyay biilkayga, ama aan u sheegay dacwoodaha inaan bixinayo lacagta oo dhan sida ugu dhakhso badan een karo. Ma lay dacwayn karaa?

Haa. Hase yeeshee, badanka dayn bixiyayaasha kuma kharashgareeyaan lacag dacwadaha waxayna kula gali doonaan heshiis in loo bixiyo qayb qayb.

Haddii aadan lacag bixin karin, la xidhiidh dayn bixiyaha. U sharax waxa dhacay. Haddii ayna wax kaa maqal, waxay kuu qaadan karaan inaad bixinaynin. Ka dib waxay kaa gudbin doonaan dacwad. Haddii ay guulaystaan, kharashka ku baxay dacwadda waxaa lagu dari doonaa cadadka lagugu leeyahay. Dayn bixiyuhu waa inuuna aqbalin wax kasta oo ka yar waxa lagugu leeyahay.

Ma bixin karo daynta. Ma lay dacwayn karaa?

Haa. Taasi difaac ma noqonayso.

Waa maxay Bayaanka Wax Ka Dhaafidda Dhaqaalaha iyo Hantida?

Bayaanka waa qoraal dhaar ah. Bayaanka Wax Ka Dhaafidda Dhaqaalaha iyo Hantida wuxuu ogaysiinayaa dayn bixiyahaaga inaad leedahay dhaqaale iyo/ama hanti uu sharcigu dhahayo lagaama qaadi karo. ¹ Sidoo kale waxay ogaysiin in haddii ay isku dayaan in la xukumo ama la mulkiyo waxyaabahaan, waad dacwayn kartaa sida uu qorayo [Qodobka Nidaamka Dayn ururinda \(FDCPA\)](#).

Waa inaad ku soo lifaaqdaa Bayaankaaga koobiga waraaqaha bangi iyo waraaqo kasta oo muujinaya ilahaaga dhaqaale. (Madoobee ama qari lambarka akoontigaaga iyo lambarka aqoonsiga shakhsi ee qoraalkan.)

❖ Waxaad isticmaali kartaa Waraaqda banaan ee Bayaanka Wax Ka Dhaafidda Dhaqaale iyo Hanti ee dhammaadka qoraalkan.

Haddii xaaskaaga/ninkaaga uu leeyahay ilaha dhaqaalaha een wax laga dhaafin, sida mushahaar, waa inay/inuu furtaa akoonti uu/ay leedahay oo ay dhigtaa lacagta aan waxba laga dhaafin halkaas. Akoontigaas waxaa la galin doonaa khatar xukun haddii xaaskaaga/ninkaaga noqdo eedaysanaha dacwadda.

¹ Ha keenin dhaqaalaha iyo hantida la seeyay wax dhaafidda xadidan ee arrimaha dayn bixiyahaaga. Haddii aad haysatid dhaqaale leh cadad wax dhaafid, waxay kugu xukumi karaan in badan. Haddii kale, ayada oon la tixgalinaynin qiimaha hantidaada, xataa haddii uu dayn bixiyuhu uuna awoodin inuu u dib u qaato, waxay sii dhigi karaan mulkiyadda ayada ee cadadka lagugu leeyahaye.

Waa maxay Wicidda Maxkamadda iyo Cabasho?

Qofka bilaabaya dacwadda waa inuu diyaariyaa qoraal u sheegaya garsooraha waxa ay dhibaataadu tahay iyo waxa ay/uu doonayo. Qoraalkan waa **Cabasho**.

❖ Qofkan bilaabaya dacwadda waa dacwoode. Haddii dacwaddu kadhan kugu tahay, waxaad tahay eedaysanaha.

Dacwodoohu waa inuu haystaa koobi ah cabashada uu ku siiyo adi sidaa darteed waxaad ogaan doonta dacwaddu waxa ay tahay.

Waxaad sidoo kale heli doontaa **Wicitaanka Maxkamad**. Kuu sheegaysa:

- waxaad xaq u leedahay inaad ku diidid Cabashada qoraal
- imisa wakhti aad kaga jawaabaysid Cabashada
- Meesha la geenayo Jawaabtaada

Haddii aadan maxkamadda ugu sheegin qoraal in aad diidantahay qoraalka Dacwadda, garsooruhu wuxuu u qaadan doonaa inaad ogoshahay wuxuuna sida caadiga ah siin doonaa dacwoodaha waxa ay/uu codsaday. Dacwooduhu wuxuu ku guulaysan dayn bixin la'aanta haddii aadan ka jawaabin. Haddii maxkamaddu xukunto Xukun Dayn Bixin La'aan oo kadhan kugu ah, ma heli kartid ogaysiis haddii aadan ka jawaabin.

Marka dacwooduhu helo xukunka kadhanka kugu ah, wuxuu/waxay awoodi kartaa inay

ka qaadato lacag akoon bangigaaga ama jeegaaga, ama wuxuu qaadan qaar hantidaada ah in lagu bixiyo xukunka. Waa inaad keentaa **jawaab qoraal** ah wakhtiga loo xadiday gudahiisa Wiciddaada maxkamadda (badanaa waa labaatan cisho. Akhri Wicitaanka maxkamadda wakhtiga kama danbaysta ah si daxadar leh).

Waxaad ku jawaabi kartaa u gaynta qofka siixay Wicitaanka maxkamadda iyo Dacwadda mid:

- Ogaysiiska Imaanshaha AMA
- Jawaab

Ogaysiiska Imaansho wuxuu sheegaa in aad imaatiid dacwadda. Keenidda Ogaysiis Imaansho waxay ka celin maxkamadda soo rogidda xukun dayn bixin la'aan kadhan kugu ah adoon joogin. **Ogaysiiska Imaanshaha ma sharaxo booskaaga dacwadda. Jawaabtaadu waxay noqon tan.**

Isticmaal foomka Ogaysiiska Imaanshaha ee qoraalkan. (Waxaan sidoo kale ku soo darnay tusaale Ogaysiis.) Ku dadaal Ogaysiiska Imaanshaha iyo Jawaabta inaad labadaba samaysid isku mar. Ugu yaraan waa inaad samaysaa Ogaysiiska Imaanshaha. Haddii aad keentay ood soo dhigtay ka hor dacwoodaha inta uuna tagin maxkamadda, waa inay/inuu ku ogaysiiyaa dhammaan dhagaysashada maxkamadda ee mustaqbal.

◆ **Qorshee inaad keento ood soo dhigto Jawaabtaada kahor inta aadan tagin maxkamadda.** Adeegso foomka jawaabta ee qoraalkan. Tilmaamaha buuxinta waxay ku yaalaan hoos.

Waa maxay Jawaab?

Waa qoraal jawaabtaada qoraalada Dacwadda. Waxaad tahay eedaysanaha.

Jawaabtaada, ma:

- sheegayso sheekada oo dhan
- samaynaso talo bixinno sharci

Waxay:

- sheegaysaa in aad ogoshahay ama aad diidantahay qoraal kasta oo dacwadda ah, ama in aadan ogayn haddii qoraaladu ee Dacwadda ay dhab yihiin
- Qor ama si daxadar leh u daabac jawaabtaada. Jawaabtaadu waa inay cadahay oo la akhrin karo
- Adeegso oo kaliya warqad ah 8 ½ X 11" (cabirka boggan)

Buuxinta Jawaabta wakhtiga, waxaad ilaalinaysaa xuquuqdaada si looga dodo wax ku saabsan arrintan maxkamadda iyo in la helo ogaysiiska dhagaysiyada mustaqbalka.

Waxaad ku soo gaadhi kara dhibaato ama danbi dayn qabidda. Waxaad dooni kartaa

uun dhammaan in la dhameeyo. Waxaad dareemi kartaa inaad u qalanto ganaax ood rabto garsooraha inuu ku ganaaxo. **Waxaad wali keeni kartaa jawaab. Ma ahan micnaheedu inaad isku dayaysid inaad ka hortagayso daymaha sharciga ah.** Waxaad diidi kartaa cadadka lacageed ee dacwooduhu ku soo dhigay Dacwadda. Waxaad dooni kartaa inaad ilaaliso xuquuqdaada si aad u hesho ogaysiiska dhagaysashada mustaqbalka. Haddii aadan keenin Jawaab, waxaad waayi kartaa inaad dhahdo imisa ayaad filaysaa inaan bixiyo.

◆ Haddii aad keentid Jawaab ood waydid kiiska maxkamadda, waxaad ku yeelan kartaa dacwoodaha kharash badan oo maxkamadda ah iyo kharashaadka qareenka.

Waxaad u baahan doontaa hal orjinaal ah iyo labo koobi oo warqadda Jawaabta ah. Waxaad keeni doontaa orjinaalka maxkamadda. Hal koobi waxaa loo gayn dacwoodaha. Waxaad haysan koobi. Qaybta hoose, "Maxaa lagu qaban Jawaabta," waxay sharaxaysaa wax badan.

Sideen u buuxiyaa Jawaabta?

A. Araar

Fiiri Wicitaankaaga Maxkamadda iyo Dacwadda. Waxay leeyihiin ciwaan ku siinaya xog ku saabsan kiiska. Ciwaankan waa "araar." dhammaan waraaqaha maxkamadda, ooy ku jiraan Wicidda Maxkamadda, Dacwadda, iyo Jawaabtaada, waxaa loogu yeedhaa "waraaqaha maxkamadda." dhammaan waraaqaha maxkamadda waxay qaataan araarta noocan ah.

Araartu waxay u egtahay sidan:

- Laynka sare wuxuu bixiyaa magaca maxkamadda, gobalka, iyo dagmada. Tusaalayaal: "Maxkamadda Heer Dagmo ee Washington ee Dagmada Pierce" ama "Maxkamadda Sare ee Gobalka Washington ah iyo Dagmada Pierce."
- Dhanka bidix wuxuu taxaa magacyada Dacwoodaha iyo Eedaysanaha.
- Dhanka midig wuxuu taxaa **lambarka** xafiis-hayaha maxkamadda uu ugu tala galay kiiskan sidaa darteed waxay u keeni karaan si saxan) iyo **ciwaanka** warqadaas maxkamadda.

Haddii waraaqaha aad heshay ayna lahayn fayl lambar, dacwoodaha wuxuu go'aansan karaa inuu u keeno (ama usoo dhiibo) waraaqaha adiga inta uuna gaynin maxkamadda. Sharcigu wuu ogalyahay tan. Waxaad wali ku khasbantahay wakhtiga xadidan ee ku qoran Wicitaanka maxkamadda. Balse ma ahan inaad Jawaabtaada keentid maxkamadda. Waxaad wali siin doontaa koobi qareenka dacwoodahaaga (ama dacwoodaha haddii ayna/uuna haysan qareen). U akhri Wiciddaada maxkamadda si daxadar leh. Waxay kuu sheegi wax aad samaynaysid.

Marka aad buuxisid Jawaabtaada, buuxi araarta ee dhanka sare ee bogga. Koobiyee xogta loo baahanyahay ee Wicitaankaaga maxkamadda iyo Dacwadda. Koobiyee magacyada dacwoodaha iyo eedaynaha **sida ay ugu qoranyihiin Wicidda maxkamadda iyo Dacwadda**, xataa haddii ay magacaaga u hingaadiyeen khalad ama laguugu yeedho ama xaaskaaga/ninkaaga "John Doe."

B. Ogolaanshayaasha/diidmayaasha

Ka dib buuxinta araarta, isticmaal badhtamaha bogga si aad u bixisid jawaabtaada ee qoraalka Dacwadda. Badanaa, Qormooyinka Dacwadda waa la galin lambarro. Waxaad tixi kartaa lambarada waxaadna wax ka odhan mid ka mid ah saddex waxyaabood qormo kasta oo dacwadda ah:

1. Waxaad **qiraysaa** in ay tahay qoraal run ah. (Tusaalayaal: in aad ku nooshahay Dagmada Pierce, ama in aadan ahayn xubin ka mid ah Ciidamada.) Qir qoraalka kali ah haddii aad ogoshahay **qayb kasta** oo ka mid ah. Haddii kale, diid qoraalka.
2. Waxaad **diidi** in u qoraalku run yahay. (Tusaale: in uu kugu leeyahay cadad kooni ah oo lacag ah qofka la dhaho.)
3. Waxaad qortaa in aadan war u hayn in qoraalku run yahay iyo inkale. (Tusaale: hay'adda dayn ururinda taasoo kugu dacwaynaysa sheegashooyinka inay yihiin kuwa sharciyaysan oo wada shaqayn la leh. Waxaad malaynaysaa in ay yihiin, laakiin wax cadayn ma haysid.

Abid maadan arag laysinkooda sharci.)

U akhri Dacwadda si daxadar leh. Waa inaad si kooban uga jawaabtaa **dhammaan qoraalada ku jira.**

Haddii aad gabi ahaanba diidantahay wax kasta oo Dacwadda ah, qor uun jumlad qudh ah sheegaysa inaad diidantahay mid kasta iyo eedayn walba oo Dacwadda ah.

◆ Ha diidin waxyaabaha aad ogtahay in dhab yihiin.

C. Difaacyada

Waxaad yeelan kartaa difaacyo sharci ama farsamo Dacwadda, sida doodid in **muddada xeerka daynta la dhaafay.** Tilaabooyinka lagu qaadaaya daymaha waxay leeyihiin wakhti xadidan oo loo yaqaan "muddada xeerka daynta." Badanaa waxay bilaabataa marka dayn bixiyuhu xaq u helo inuu dacwad kaa geeyo (tusaale: marka aad waydo lacag bixin). Marka muddada wakhtiga la dhafo, dayn bixiyuhu dayn kaama qaadan karo. Maxkamaddu waxay diidi doonta wax ka qabad.

Xog dheeri oo ku saabsan Muddada Xeerka Daynta, ka wac CLEAR haddii aad dhaqaalo yartahay (1-888-201-1014, M – F 9:10 galin-hore – 12:25 galin-danbe) ama fiiri [Xeerka La Cusboonaysiiyay ee Washington](#) (RCW). Waaxda tixraaca ee magtabadda xaafaddaada waxay awoodi kartaa inay ku caawiso helidda qaybta saxda ah ee Xeerka La Cusboonaysiiyay ee Washington (RCW).

Waxaad sidoo kale ka doodi kartaa is difaac ahaan **inaad lacagta lagugu** layahay. Xataa haddii aad gadatay wax kaasoo dacwooduhu dacwadda ka gaynayo,

waxaba laguguma lahaan karo haddii shaygu ciladaysnaa ood soo celisay, ama aad isku dayday inaad soo celiso.

Waxaad waayi kartaa “Is Difaac Ahaan” haddii aad gaysid warqad Jawaab ah oon sheegaynin.

◆ [Qodobka 8\(c\) ee Qodabka Madaniga ee Maxkamadda Sare](#) sidoo kale wuxuu qoraa is difaacyada.

D. Kadaba sheegasho

Waxaad dooni kartaa inaad samayso dacwado ka dhan ku ah dacwoodaha. Waa **inaad** ku sheegtaa dacwadahan Jawaabtaada haddii ay sababeen hawl isku mid ah ama arrinta dacwooduhu dacwadda ka gudbinayo.

Tusaalayaal: haddii iibiyaha alaab kugu dacweeyo daynta iibsashada alaabta taaso oo ciladaysnayd oo wax ku yeeshay, waa inaad ku sheegtaa dacwad kasta ood rabtid inaad ka gayso iibiyaha/gadaha, dacwoodaha ee jawaabtaada. Haddii dacwooduhu sharciga Dayn ururinda (fiiri [Xuquuqda Dayn Bixiyayaash – qoraalka Hay’adaha Dayn ururinda](#)), waxad yeelan kartaa sheegasho khasaare oo kadhan ku ah dacwoodaha. Ka ogaw qareen ama sharciga maxkamadda wax badan oo ku saabsan ka daba sheegasho.

◆ Haddii aad doonaysid inaad samayso ka daba sheegasho, waa inaad bixisaa lacagta buuxinta foomka si loo geeyo Jawaabtaad. Dagmooyin dhawr ah waxay kuu ogolaan karaan inaad isku daydid in lagaa dhaaf lacagta. Waydii xafiis-hayaha maxkamadda nidaamyada heer deegaan. Haddii aadan qorshaynaynin inaad keento ka daba sheegashada, ka saar meesha “kadaba sheegadka” ee araarta, salka, iyo jumlada ugu danbaysa ee jawaabtaada. Haddii kale, xafiis-hayuhu wuxuu isku dayi karaa inu kugu dallaco lacagta buuxinta.

E. Dhaqaalaha wax laga dhaafo

Haddii dhaqaalahaaga laga dhaafo xukunka wax bixin. Waa inaad ku qortaa qormo jawaabtaad oo sheegaysa sidaa. Tusaale: haddii dhaqaalahaagu yahay Kaalmada Dawladda oo kali ah, taasoo uu ka dhaafay wax bixinta sharciga fadaraalka, hadaba ku qor jawaabtaada waxa soo socda: “Dhaqaalahaygu wuxuu ka koobanyahay oo kali ah Kaalmada Dawladda.” Tani ma ahan difaac dacwadda. Waxay ogaysiin dacwoodaha in dhaqaalahaaga laga dhaafay xukunka wax bixinta oo kali ah. Haddii dacwaddu ku seegto oo dacwooduhu ka dib xukumoo bangi akoontigaaga laga dhaafay wax bixinta, waxaad qaadi kartaa tilaabo kadhan ku ah dacwoodaha.

F. Saxiixa iyo Ciwaankaaga

Bogga ugu danbeeya, ku qor taariikhda magacaaga ku saxiixan. Dhankaa hoose, ku saxiix magacaaga oo leh saxiixaaga sharciga ah (kaad u adeegsatid jeegagga). Ha ahaado saxiixaadu xagga hoose, ku qor magacaaga sidaa darteed si fudud ayaa loo akhrin doonaa. Ku qor ciwaankaaga dhanka hoose. Waxaad dhamaysay Jawaabtaada.

Ciwaankaaga: Ku qor ciwaan meesha aad waraaquhu ka soo galaan oo **gacan lagu keeno**. Ha adeegsan P.O. Box. Ogaysiisyada Dhagaysiyada waxaa laguugu soo diri doonaa ciwaankaas. Haddii aad imaan waydo sababtoo ah maadan helin ogaysiis, maxkamaddu waxay kugu soo rogi kartaa xukun adoo maqan.

Seen u buuxin Bayaanka Dhaafidda Dhaqaale iyo Hanti?

- Qaybaha 1 – 3: Dib u akhri “Waxay tahay Jawaabta” qaybta in la buuxiyo bogga koobaad ee bayaanka.
- Qaybta 4: Sax sanduuq kasta oo khuseeya dhaqaalaha aad heshid. Tusaale: Waxaad heshaa Dhaqaalaha Kaalmada Dheeriga (SSI). Waxaad sixi sanduuqa labaad ee qaybta 4.
- Qaybta 5: Samee wax la mid hantida/guriga aad leedahay. Tusaale: Waxaad leedahay magtabad qiimaheedu yahay \$1,000. Waxaad sixi sanduuqa afraad ee qaybta 5.
- Qaybta ugu danbaysa bayaanka: Saxiix bayaanka kuna qor taariikhda aad saxiixday, saxiixa, waxaad ballan qaadaysaa in dhammaan xogta aad qortay ay tahay dhab. Haddii aad ku

buuxisid qayb ka mid ah bayaanka waxaan run ahayn, waxaa lagugu soo oogi karaa been dhaarasho, qaybta danbiga B. Haddii lagugu soo oogo inaad been ku dhaaratay bayaankan, tan waxaa loo qaadan khiyaamo. Dabadeed waxaan shaki ku jirin inaad ku bixin doonto daynta dacwaddan mooro dug. Dayn bixiyayaashu aad bay ugu fiicanyihiin ogaanshaha hantida iyo dhaqaalaha aad leedahay. Daacad u noqo bayaankan.

- Ku lifaaq waraaqda kaalmadaada dawladda iyo warqadda bangigaaga. Waa inaad ku dartaa lambarka aqoonsiga laftirkiisa iyo lambarka akoontiga bangiga.

Maxaan ku samayn dukumiintiyadan marka aan buuxiyo?

A. Keenis

Ka samee ugu yaraan labo koobi Jawaabtaada iyo Ogaysiiska Imaansho. U keen qareenka dacwoodaha warqad kasta hal koobi. Qor magaca qareenka iyo ciwaanka dhanka midig ee hoose ee waraaqaha Wicidda iyo Dacwadda. Haddii dacwooduhu naftiisa u taaganyahay, sii koobiga waraaqaha dacwoodaha. Haddii aadan doonaynin inaad u geeso laftirkaagu saaxiib aamin ah ha kuugu geeyo.

Waa inaad gaysaa koobiga Jawaabtaada ama Ogaysiiska Imaansho wakhtiga ama ka hor wakhtiga Wicidda. **Waa inaad ku gaysaa Jawaabtaada iyo Ogaysiiska Imaansho wakhtiga.**

Waa inaad u gaysaa koobiga dukumiinti kasta qareenka dacwoodaha shakhsi ahaan.

Waxaad kaga tagi kartaa warqadaha xog-hayaha ama soo-dhaweyaha. Ka codso soo-dhaweyaha inuu shaabadeeyo orjinaalka iyo koobiga dukumiinti kasta oo “koobi laga helay” shaabad muujinaysa wakhtiga la qabtay. Tani waxay cadayn doontaa in aad ku keentay dukumiintiyadan wakhtiga ee Wicitaanka.

Haddii aad u dirtid dukumiintiyada qareenka dacwoodaha, waa inaad siisid wakhti ku filan si loogu keeno wakhtiga kama danbaysta ah (ugu yaraan saddex cisho). Kuma filna Jawaabta iyo Ogaysiiska Imaansho in lagu shaabadeeyo wakhtiga ama ka hor. Qareenka dacwooduhu waa inuu ku helaa wakhtiga loo qabtay Wicitaanka. Haddii aad u dirto Jawaabta, waxaad ku diri kartaa hal Jawaab boostada caadiga ah midna boostooyinka sare, codsiga helidda soo noqoshada.

◆ Gacan ka dhiibid baa wanaagsan.

Haddii aad dirtid Ogaysiiska Imaansho iyo/ama Jawaabta, maxkamaddu waxay u baahantahay caddaynta diridda. Buuxi Adeegyada caddaynta. Ku lifaaq orjinaalka dukumiintiga eed dirtay. Adeegga caddaynta fudud iyo foomka Adeegga caddaynta waad isticmaali kartaa qoraalkan. Ka samee koobiyo dheeri ah foomka inta aadan isticmaalin ka hor.
